

Committee Reports Our Second Annual Christmas Tree Sale Project Successful

With the support and cooperation of most of the club members, the men from the Salvation Army at Lytton, high school students, members of the Cloverdale Kiwanis, other volunteers and the help of employees Kelly Brewer and his son Kyle, The Christmas Tree Lot Committee deemed this year's project a success.

Ken Scharer, chairman of the project, said that he figured the project grossed between \$105,000 to \$107,000 even though the lot did not sell all of the trees by December 24. There were 184 trees not sold according to committee member Roger Dormire. Roger said that when he closed the lot early Christmas Eve he placed 5 or 6 trees outside the fence. And they were all gone when he returned later, hopefully picked up by needy families.

Ken said that the final tally won't be availale until all the bills are in and an accounting can be made.

The money raised from this project will go to help the youth of the community including the Boys and Girls Club, Boy Scouts, scholarships, supporting the Key Club, etc.

Many long hours were put into the project by the committee: Ken Scharer, chair, Roger Dormire, Joe Engler, Lockie Gillies, Chris Metrulas, Dennis Stead. Again this year Beverly Dordahl took over the duties of cashier assisted by Dee Whitehall and Al (Pete) Peterson.

Kiwanians Have A 'Wrapping' Good Time Helping with Christmas' *Project Presents*

Twelve Kiwanians and family members volunteered to wrap Christmas presents for needy families at the Healdsburg Senior Center on Friday, December 17. The program, *Project Present/ Adopt a Family*, provided new gifts and clothing for 59 families, totaling 259 individuals.

Marcia Lavine who has spearheaded this project for the past four years said that approximately \$4,000 was raised in a very short time and the funds were channeled through the Kiwanis Club so that those donating could use the donation as a tax write-off. The club opted to adopt a family of six with Past President Nancy Curnow volunteering to purchase the gifts. Out of the 59 families,46 were adopted by organizations, business firms or individuals. Volunteers wrapped the gifts for the 13 remaining families. 13 bicycles were donated for 12 youngsters and one man and were to be picked up at the Healdsburg Police station where licenses would be issued.

The families were advised to pick up their beautifully wrapped gifts all labeled carefully and placed in large plastic bags on Friday afternoon at the Senior Center. The names of the recipient families are carefully guarded and are provided by the Healdsburg School District, Evenstart Preschool and 4C's Day Care. The sponsors and families are kept anonymous.

Committee Will Report Back On The Memorial Scholarship Fund Change

Following a report by the Healdsburg Kiwanis Memorial Scholarship Committee to the membership at large at the December 7 meeting, the consensus was to study the proposal further. It was suggested by the Scholarship Fund committee that the method of investment of the funds, approximately \$100,000, be changed. Presently the funds are invested in certificates of deposit with a low rate of interest. It was suggested that the management of the funds be turned over to Sonoma County Community Foundation so that a higher rate of return be achieved/

The committee would then be out of the management business, Chuck Reichel said.

However, Tom Rackerby, chairman of the Scholarship Awards committee, voiced opposition to the change in management pointing out that in his dealings he found the Foundation lacking.

The committee, along with Tom Rackerby, will study the proposal and report back to the membership with further plans or ideas.

Funding Approved By Board

The board of directors at its December 9 meeting approved three funding requests, denied one request for funds and discussed the possibility of creating a co-op garden with

the fruit and vegetables grown donated to the Food Pantry as suggested by Chris Metrulas.

Approved was a request from the Healdsburg Preschool Co-op with the funds going to the replacement of a furnace at the school. The club will match up to \$1,000 of any funds raised by the Co-Op itself and parental donations but exclusive of funds donated by other service clubs.

Also approved was a request by the Healdsburg Bulldogs Junior Cheerleaders for funds to go towards their placement in and a trip to the U.S.A. Junior Spirit National Competition. The club will match up to \$500 of funds raised by the Cheerleaders or their parents but not donations from other service club.

\$600 was approved to buy Christmas gifts for a needy family of 6 as a part of the Project Presents/Adopt A Family Program. Nancy Curnow was authorized to shop for the gifts.

Chris Metrulas offered to donate a newly refurbished printer to the Healdsburg Community Nursery School. So the board denied the school's request for \$400 for a new printer.
