Innovative Membership Drive Underway; First Evening Meeting Set for February 23

Starting off with a half page colored advertisement in the Healdsburg Tribune, followed by a front page article in the Tribune by Tribune editor Kerrie Lindecker, Membership Drive chairman Rick Norman and his committee have undertaken an innovative and novel approach to bringing new members into the club. The new proposal, with the concept of making the club more accessible to area business and profesional residents will consist of three luncheon meetings and one evening meeting. The first evening meeting will take place at 7 p,m. on February 23 at the Villa Chanticleer annex. Dick Bugarske, program chairman, is hoping to bring new and exciting programs and speakers, especially to the evening meetings.

Under the new program there will be a number of categories – regular members, senior membership and associate. The dues structure will also change with the new program beginning April 1. Regular members will pay \$120 a quarter, down from the present \$160, senior members will be charged \$60.00 a quarter and when they attend \$13.50 for the lunch. Associate members will also pay \$60.00 per quarter and will opt to pay for a meal. There will be no meal served at the evening meeting.

President Loretta Strong who has enthusiastically endorsed the new proposal urges all the members to be active participants. She stressed bringng a friend, relative, business associate, church member, volunteer organization personnel to let them see how we operate and what our mission is. We are here to help the children and youth of our community and the more members we have the more we can do for the community. Rick announced that he had received 4 responses so far to the advertisements.

The committee suggests that you never recruit someone to join Kiwanis. Instead, invite them to be your guest at a meeting or to join you to

work on a service project, The experience of meeting other club members and seeing Kiwanis in action will make them want to join.

Remember that someone once liked and respected you enough to ask you to be their guest at a meeting. Keep that spirit alive as you continually look for opportunities to invite potential members to be your guest.

Board Hears Report On Financial Condition of Scholarship Fund, Approves Donations

Dennis Stead, a director of the Healdsburg Kiwanis Memorial Scholarship Fund, advised the club's board of directors at the January 21 meeting that the Fund had a fiscal-year end (9-30-09) value of \$153,390, with approximately \$9,000 more value as of January 21. He said that the Fund had received \$5,850 in interest, dividends and contributions during the prior fiscal year and that the net profits-for the 2009 Foot Race were approximately \$5,500. Dennis added that on a preliminary basis the Scholarship Fund board was anticipating that \$5,000 would be available for distribution for high school scholarships in 2010.


In other business, the board approved a donation of \$500 to North County Community Services for the purchase of shampoo and soaps for the residents of Victory Apartments which include transitional and low income housing and for fund raising brochures.

Also approved was a contribution of \$100 to the Ann and Art Weaver Division 32 Scholarship Fund which chooses one division club annually and enables that club to make a substantial scholarship grant.

Secretary Phil Luks reported on the status of the new by-laws. It was agreed that he would draft a memo outlining the mechanics of a system in which the president served for two years and the vice-presidents for one year. The new by-laws, with the retention of a one-year term for the time being, would be brought to the board for approval in February.

The catering services of Patti Robarts who has been serving our lunches on an interim basis were retained on a permanent basis.

President Loretta Strong reported that the half page ad for the Membership Drive cost the club \$600 and that the color was free. She said that the smaller ads which would appear in February before our kick-off evening meeting would cost about \$230. The ads will be appearing on our websites. Financial Health of Club Funds

The financial health of our Administrative Fund and the Projet Fund for the fiscal year ending 9-30-09 are in good shape.

The Administrative Fund opened on October 1, 2008 with a cash balance of \$6,300 and ended on September 30, 2009 at \$5,800.

Revenue sources were: \$40,600 dues; \$7,000 Brandt's Beach Auction; \$4,200 Senior and Guest lunches; \$2,000 Golf Tournament; \$1,600 Fines/Happy/Sad; and \$500 Soroptimist Beer Fest.

Principal expenses were: \$37,000 lunch; \$4,500 Kiwanis International dues; \$2,800 dues for Division 32; \$3,600 Villa rent (one full year), \$2,200 insurance; \$3,300 Administrative; and \$3,000 Project Fund Working Capital Loan Repayment.

The Project Fund opened on October 1, 2008 with \$55,000 and ended on September 30, 2009 at \$69,000.

Revenue sources were: \$37,000 Tree Lot; \$12,000 Pancake Breakfast; \$8,000 Future Farmers Country Fair booth; \$3,000 Administrative Fund Working Capital Loan Repayment; \$1,900 Investment Interest; and \$550 Chris Metrulas donation,

Principal expenses were: \$16,000 Healdsburg Schools; \$7,000 Recreation Park improvements; \$5,000 Habitat for Humanity; \$4,800 Scholarships; \$4,200 Scout Troop 21; \$3,000 Salvation Army Kitchen repairs; \$4,000 local charities; \$2,000 American Legion Fireworks; and \$2,000 miscellaneous local projects, the donations totaling \$48,000.

Jim Birdsong Submits Resignation
