Kurt Hahn, our city's manager of financial arrangements, gave us a rundown on where our tax dollars that we so grudgingly shell out go, and why. We live in what is known as a "full service" city; that is, it owns the electric supply, the sewers, the water supply, and the airport! And each of 'em can prove that they need more money!

Property taxes only take care of 5% of the city's budget, sales taxes 11% while subdivision and development fees are one of the major sources of income.

He then went on to explain where some of the City's money goes; improvements are being made at the airport, fringe benefits of the City employees are improving but costing more (about ½ million a year right now); to improve water flow fire hydrants will be moved closer together and more put in (the city's dogs are eagerly looking forward to this development) to mention but a few of the many things needed to be

Two of several ways that will bring income so that the above noted improvements can be made, will be by increasing traffic enforcement and issuing tickets to those that violate the rules, and increased ticketing of cars who over-stay the one hour limit for on-street parking.
