Kiwanis announces safe meeting guidelines, insurance changes

Kiwanis Update Newsletter

Some Kiwanis clubs have resumed in-person meetings and events. For those clubs, and clubs considering that option, Kiwanis International has compiled guidelines to help them serve safely with adequate health protocols.

Club, division and district leaders should also have attendees complete an event health checklist and a release of liability and assumption of risk waiver. Starting November 1, 2020, the Kiwanis Insurance policy will no longer cover claims related to someone claiming that they became infected with COVID-19 at a Kiwanis meeting or event.

Guidelines for in person meetings:

- Follow all federal and local laws.
- Coordinate with the meeting venue regarding seating requirements (at least 6 feet), mask requirements, food service, cleaning of surfaces etc.
- Consider requiring all attendees to obtain a negative COVID-19 test before the meeting. This should be strongly considered for any gatherings of 50 or more people.
- Require all attendees at meetings to sign a waiver that states anyone who believes she/he may have contracted COVID-19 at a Kiwanis event waives all related claims against any Kiwanis club, district or Kiwanis International. Any meeting of youth members (under 18 years) in the Kiwanis family will require a signature from a parent or legal guardian. A sample waiver is included here.
- Conduct temperature tests on all attendees before entering the meeting area. Anyone who has a temperature of 100.4 degrees Fahrenheit or 38 degrees Celsius or above should be excluded from the meeting.
- Ask all attendees to certify that they have not experienced any common COVID-19 symptoms in the last 72 hours. A list of common COVID-19 symptoms is included here.
- Ask attendees to wear a mask when attending any indoor meeting. There is increasing scientific evidence that masks substantially reduce the chances of spreading COVID-19 infections.


Board of Directors Meeting

Healdsburg City Council candidates

The six City Council candidates for the November 8 election were scheduled for 30-minute presentations at our Tuesday Zoom meetings leading up to the election. David Jones, Charles Duffy and Skylaer Palacios visited in September. The remaining 3 candidates visited in October, see below.

Information about the candidates is extracted from candidates' statements in the County of Sonoma voter guide, see voter guide for full text.

October 6 - Ariel Kelley County Planning Commissioner

non-profit executive, community leader, Sonoma County Planning Commissioner, attorney, and mom to two children. I'm running for City Council because I believe



we can work together to create a thriving and sustainable Healdsburg for everyone.

I'm dedicated to improving our quality of life. I co-founded Corazón Healdsburg, a local nonprofit focused on supporting residents and families through innovative programs, such as Kinder2 College which established college savings accounts for every Healdsburg public school student. In the wake of the Tubbs Fire and again after the Kincade Fire, I created the Healdsburg Free Store, which provided free clothing and supplies for thousands of families. As Sonoma County Planning commissioner, I supported policies that created affordable housing while preserving agricultural land.

October 15 - David Hagele Council member/Former Mayor/Business Owner/Father

I'm running for Healdsburg City Council continue providing inclusive leadership on the most pressing issues facing Healdsburg today: supporting local business and working families during this pandemic;



focusing on Healdsburg's health and safety; and preserving our smalltown character by serving as a voice for local families, longtime residents and young people who call Healdsburg home.

Serving as Mayor during the Kincaid Fire was one of the most difficult periods during my time on the Healdsburg City Council; however by

engaging with neighbors, City staff and first responders to keep Healdsburg safe, we emerged as a more resilient city that's strengthened our sense of community. As Mayor, I led Healdsburg in securing apartment buildings to preserve affordable housing for our most vulnerable neighbors. It's my hope to continue bringing people together with creative solutions to address the challenges facing our City.

October 20 - Doralice Handal, Businesswoman

I am running for City Council because I believe that including diverse and underserved voices in decision-making will help us create a more inclusive, safe, and solvent Healdsburg. I bring to the position a spectrum of



experience enabling me to take into account Healdsburg's multiple needs. I understand the challenges of local businesses, as operator of The Cheese Shop and Denier-Handal Vineyards. As a Volunteer Spanish Translator for Reach for Home, I am keenly aware of housing affordability. And as someone with a chronic disability, I bring to the Council a unique voice on accessibility concerns.

Oct. 27 - Dr. Jason Shogren - U. of Wyoming - The economics of climate change.

Dr. Shogren Department Chair and Stroock Professor of Natural Resource Conservation and Management in the department of Economics at the University of Wyoming.



He studies the behavioral underpinnings of economic policy. He is an internationally respected economist who was a member of the Intergovernmental Panel on Climate Change that shared the 2007 Nobel Peace Prize with former Vice President Al Gore.

In his very interesting presentation, Dr. Shogren discussed the economics of climate change policy; the risks that climate change poses for society, the benefits of protection against the effects of climate change, and the costs of alternative protection policies. The discussion encompassed the following principles all of which come with challenges:

- Costs and benefits matter in assessing climate change policies, as does the uncertainty surrounding them.
- Well-designed, cost-effective climate policies are essential in addressing the threat of climate change.
- Coherent international agreements are key to successful policy implementation.

Dr. Shogren is guardedly optimistic regarding moving away from fossil fuels to renewable sources considering the recent advances in wind and solar technology and that these sources are becoming more cost competitive. Remaining challenges include the storage bottleneck: need for development of high capacity storage (batteries) and the NIMBY attitude (we don't want those ugly windmills in our back yard).
